Treasurer's Report (Dr. Furlong): Finances are in good standing

Secretary's Report (Dr. McTaggart):

NJDA component representatives to the state council report to be sent in. Thank you for sending in your trustees reports in a timely manner. 191 letters to non-MOCDS new dentists were mailed in February, 2012 to invite to the new member meeting. 39 letters were mailed to dental schools in Pennsylvania, New Jersey and New York and Residencies in New Jersey. We have received many responses. We hoped to have 50 prospective new dentists attend and there is still time to receive more responses. Here is the breakdown for table sponsors:

Secretary's Report including Dues Waivers (Dr. Angowski): Trustees discussed NJDA policy on dues wavers. Will progress with discussion on potential changes in bylaws to assure MOCDS is having their component members fairly represented. Dr. Angowski will follow up on dues statistics with NJDA.

NJDA Trustee Report (Dr. Shah): NJDA January 2012 BOT

The NJDA is a recipient of grant money from the ADA for the

2011-2012 and 2012-2013 Membership Program for Grant Initiatives. We received a \$15,000 award for each for a total of \$30,000 towards recruitment efforts specifically targeting female and members of Indian Dental Association of North America. Council on membership approved to use part of this money to run a workshop by an immigration attorney on visa and residence issue for foreign national dentists who are graduate students, residents, temporary workers and contemplating permanent residence through employment in dentistry. MOCDS felt strongly that in this economical times, NJDA and ADA, especially when raising dues this year, should be prudent with their spending, our resources should first be allocated towards our existing members and those who are likely prospective members in the immediate future(NJ practicing dentists members of IDANA but not member of NJDA), before we consider providing a service (however helpful it may be) to those who are possible members several years in the future (at current time it takes 4-8 years for immigrant dentists to get work permit). MOCDS made a strong presentation on what was best for our organization and for our profession. Suggestion was made to keep it as a weekend program(as we usually get sponsor and speaker usually comes for free), answer was that this attorney does not work or give speech on weekend. Suggestion was made to find an attorney who works on a weekend but NJDA Board (approved by the Council on Membership of a course on immigration law) determined that the course would be held. The second concern from the observation of many years at NJDA was, to make NJDA board meetings more productive, effective and financially prudent, to collect staff reports via e mail 10 days in advance, so that board members are informed and prepared ahead of time and have the privacy to discuss and determine the issues among board members and guiding the staff to achieve the results, to gain the balance of decision-making authority between staff and dentists. Executive Session was held at the beginning of the Board meeting. Dr. Shah recommended that the Board meet without staff to promote full and uninhibited discussion. The Board concluded that staff should be present except when it would be inappropriate due to the subject matter being discussed.

ADOPTED by the Board (Vote #2 BT-12-1-2) to set aside \$2500. from NJDA Income Account to inprove Access to Care as it relates to SmileCheck.

ADOPTED by the Board (Vote #3 BT-12-1-3) to lease the Hyundai Sante Fe for three years to replace the current company van.

ADOPTED by the Board (Vote #4 BT-12-1-4 to purchase a roof top air conditioning unit to replace the existing unit that needs repair.

ADOPTED by the Board (Vote #5 BT-12-1-5) to subsidize Monmouth-Ocean's recruitment effort to be held in March 2012 up to \$500.00

At the January 4th State Board meeting, Mr. Meisel raised the issue on injectable pharmacologics regulations to the board and some State Board members realized that they created quite a problem. Mr. Meisel reported that the AGD Board was looking into the problem. He feels we need to comment further and the Board agreed. He will be filing a petition for certification with the Supreme Court in the lawsuit against Horizon challenging its anti-assignment clause. The Court will then decide whether it will hear the matter. Mr. Meisel repeated that at this time dentists should not inject on the forehead or to treat crowes feet

The Executive director received the ADA's membership numbers. NJDA Component are as follows: Atlantic-Cape May- even, Bergen- loss of 13, Central- loss of 11, Essex-loss of 6, Hudsongained 6, Mercer- lost 5, Middlesex-lost 4, Monmouth-Oceanlost 16; Passaic- lost 3, Southern- lost 21, Tri-County- gained 1 and Union-lost 3. The constituents: Connecticut, Rhode Island, New York, Pennsylvania, New Jersey, Maryland and Florida lost members. Massachusetts, California and Texas gained. Nationally, the ADA gained about 600; however, there was a loss in full time active members.

Dr. Kahn report: As we have only one nominee for each office, the following is the slate of officers for the administrative year 2012-2013: President-Elect, Robert A. Giantomas; Vice-President, Bryon Roshong; Speaker of the House, Walter I. Chinoy; Gregory LaMorte, Treasurer and Giorgio DiVincenzo, Secretary. According to the Bylaws, candidates can be nominated by personal petition up to 90 days before the House of Delegates meeting at Annual Session. The deadline date for nominations by personal petition or by component society is March 26, 2012

Dr. Rosenheck will be going to Washington on February 2nd to attend a workshop to create a curriculum for all medical schools. Dr. Rosenheck reported that UMDNJ Dental School received 2300 applicants for the next year for a class of 90 students. He reported that at the Governor's Press Conference today, it was announced that the Robert Wood Johnson Medical School, the Cancer Institute of NJ and School of Public Health will become part of Rutgers. All the schools in Newark; the medical, dental, nurses and the University Behavioral Health Care will remain as a part of UMDNJ. UMDNJ will be known as New Jersey Health Sciences University. Rowan University will acquire all Rutgers' schools in Camden. University Hospital will no longer be part of UMDNJ. It will be maintained as the major hospital in NJ but run as a non-profit institution.

Council on Dental Benefits (Dr. Sirota):

Dental Benefit Plan Issues

1) Delta Dental radiograph requirement: Delta insists on a recent pa for crowns, 5+ year old films do not qualify

2) Exxon-Mobil retiree dental plan: Requires submission to Medicare first. There is no coverage, the ADA considers this practice illegal, and is negotiating with Exxon-Mobil

3) State Employee Dental Plan changes: Out of Network benefits have been cut in half from \$3000 max. to \$1500. % tables and coinsurance have also been reduced

4) The requirement to switch to electronic records under Obama care applies only to Medicare providers.

5) We need a state Health Ins. Exchange by Jan. 2014 or we go into the Federal system. We are working to get dental only plans to be part of the Health Ins. Exchange (Delta, Metlife, etc.) and working to require all plans to price med. and dental separately to allow purchasers to pick. All plans must have a pediatric dental plan.

Council on Governmental Affairs (Dr. Goodwin): COG & PA Delegates Meeting 1/11/12 LEGISLATION

All previous legislative bills from 2011 must be resubmitted after 1/1/12.

General supervision bill – there is no opposition to this bill. Expect the bill to be passed by the assembly and senate this year.

Cosmetic surgery tax repeal phase out – Assembly and Senate legislation is on Governor Christie's desk. It is expected that he will sign the bill. Note: Alergan Co. (Botox manufacturer) is planning on building a world class facility in NJ. This is further inducement for the governor to sign the legislation.



State mandate for flu vaccination – for all health care providers – has been defeated; however, this does not inhibit private institutions (E.g. hospitals) from requiring this vaccination in the future

#### NJ STATE BOARD OF DENTISTRY

Pharmaceutical injectables – should not be used above the base of the nose until regulations are clarified by the NJ State Board of Dentistry and the NJ Attorney General's Office. This includes dentists that have taken the 21 hr. (\$3,000) course in a dental school or hospital.

ADA/NJDA State Board members –all State board members are sitting beyond their appointment duration. It is interesting to note that 95% of board members are registered democrats. To date, Drs. K. Haghighi, R. Korwin & A. Rothstein have submitted resumes to the NJDA for evaluation and recommendation to be appointed to the NJ State Board of Dentistry.

#### LEGAL AFFAIRS

"Assignment of Benefits" suit – will be appealed to the NJ Supreme Court, but it may not be accepted to be heard by the Supreme Court.

Capping of fees by insurance companies, on non-covered procedures – decision pending.

"Beach Bum" tooth whitening suit – arguments being made that there is unfair competition (pricing advantage) against dentists, since dentists must practice to high standards and non-dentists may use alternative procedures or techniques to cut costs.

Insurance company's manipulation of payment – there is a practice in the insurance industry of recovering overpayment to a dentist by decreasing payment for other services – a decision is pending, possibly in 3-4 months.

#### PUBLIC AFFAIRS

"Smile Check" - an oral health initiative in which as of 1/20/12, third graders will be evaluated in 60 different schools as to their oral health, as part of a program to evaluate NJ public health policies and programs. The PEW report gave NJ an "F" in this regard, referencing public health policies. It is interpreted that the criticism is not against dentistry per se but as a promotion for the concept of promoting midlevel provider care for some populations in NJ.

#### NEW BUSINESS

Physician/Dentist Loan Redemption Program - up to \$20,000/yr. can be recovered by dentists if they work for a practice that has a sliding fee scale for different patient populations. This favors clinics against private practices, thus there is an incentive (bias) for new dentists to work in a clinic type of practice. This can be interpreted as a restriction of access to care since private practices may not be able to compete for loan forgiveness programs in certain locations. The NJDA is contemplating promoting legislation to remove the "sliding fee" mandate in this program.

Addendum: This report represents the meeting as of 1/11/12. New developments are rapidly occurring therefore I recommend following events at NJDA.org. This is another benefit of being an ADA/NJDA member.


