NJDA Trustees Report: Dr. Shah

Dr Luciano Ghisalberti, Chair of the Committee to evaluate the feasibility of Expanded Functions, reported on the January 16th meeting and scheduled the next meeting for March 6, 2013 at 10:00 a.m. At the March 6th meeting, he will discuss its findings with the Committee and report back to the Board. MOCDS position is that we should pursue opposition from a legislative standpoint. We are asking the NJDA for guidelines to address this issue with the State Board. This is against the Dental Practice Act.

Council on Annual Session: Dr Shah

Dr. Breen is upset that the Council decided to increase the price of tuition. After discussion, it was agreed that a slight increase in tuition (about \$100) and a simpler menu would help bring costs under control. During visits by Maureen and Tricia DeCotiis, components will be asked to contribute \$500 again this year. A "roadmap" to the show will be used to help sell the components on participating. Council on Dental Benefits: Dr Sirota

The Council on Dental Benefits met on Feb. 20 2013, and my report is as follows:

-CRP (complaint resolution program) statistics were reviewed as usual. There has been an increase in complaints of claims processing errors with MetLife from participating providers. The NJDA is following this closely and members are urged to contact Mary Moskal for help in resolving these issues.

-United Concordia has a new radiographic policy. PA radiographs will not be covered if taken @ a periodic exam unless a reason is provided. They claim this is a result of ADA and FDA guidelines on reducing radiation to the patient.

-Leased dental networks are becoming increasingly popular. You may find that you are participating with more plans than you remember signing up with. Insurance companies are leasing their networks to others, and usually have a right to do so as per your contract. MetLife has recently partnered w/ the Maverest Network.

Council on Dental Education: Dr Andricsak

The Council on Dental Education met on January 10, 2013. Careers in Dental education were discussed. UMDNJ has a 2 year program to become a future educator. There is on going communicate with dental assisting programs for the purpose of involving dentists of the component societies to act as liaisons of these programs. The viewpoint of the council is that these programs are supplying us with our future employees and we should be on the board of these programs to make sure we communicate as to the current needs dentists require of their auxiliaries. These girls are not necessarily getting the correct training. We are also working on communicating to our members as to the value of hiring a CDA. We want to raise awareness to our members why non CODA approved schools should not be recommended. There is a proposal to have a subcommittee to address the CODA/nonCODA issue.

The Council on Membership & the Marketing Committee will continue to work with the NJDA staff in order to develop & implement a comprehensive marketing plan.

Council on Relief: Dr Banks

John R. Kukucka, representing MOCDS for Kathy Banks The Council on Relief met on 1/16/13. I am pleased to report that our Council had \$95,000 to distribute in relief to 15 applicants, 5 of whom were from MOCDS. Half the money was donated by constituent societies from other states and the NJ Council on Relief put up the matching half.

Of the 15 applicants, 6 were deemed to be not eligible. All who applied from MOCDS (5 dentists in 4 offices) were given help. One of the offices from MOCDS has two-doctor partners, both members of MOCDS, and the Council's original intention was to only allow a certain maximum per office. However, because of the extreme loss suffered by this office, a discussion ensued and a decision was made to treat each member as a separate applicant, allowing the very badly hit MOCDS two-doctor office to get more than the individual maximum.

Although the help we are giving cannot possibly come close to covering the losses suffered by each of the applicants, we are confident that the Council acted fairly to distribute the available funds based on the extent of each individual's losses.
