From the President

I would like to wish all of you a Happy New Year filled with health, joy, and prosperity. The ADA recently reported that consumer spending for dentistry finally rose in 2010 after dropping for the first time in the past 51 years in 2008 and 2009 with the severe recession. This is certainly good news for all of us and is an indication that after a few rough years patients have again begun to care for their dental needs. As the economy continues to improve, we should expect to see pent up demand from consumers after delaying dental procedures during the recession.



For those of you who attended the January 10 dinner meeting with the NJDA officers and staffers, we heard more good news from Jim Schultz, our Director of Governmental Affairs (our lobbyist in Trenton). The night before our meeting the legislature voted to phase out gradually the Cosmetic Dentistry tax which applies to in-office bleaching and injectable pharmacologics (Botox and Juvederm). Although it still requires the governor's signature, Christie is expected to do so. This is a service that will very likely grow in dental offices, especially those directed at cosmetic and restorative dentistry. When the Dental Board approved these services as being within the scope of practice of dentistry, against much opposition from physician groups, the Board noted that dentists are more likely to have knowledge of facial anatomy and cosmetics than most physicians, all of whom are legally allowed to use these products. However, please remember that unless you are an OMFS, you must obtain the required CE training to get involved in this growth area for dental practices. The Jersey Shore Medical Center Dept. of Dentistry offers one of the first State Board approved courses at a reasonable cost and has one beginning in March. If interested, contact Dr. Paul Condello for more information.

Speaking of our lobbyist, it is important to note that organized dentistry is able to communicate our stand on issues to our elected officials precisely because of the good relations Mr. Schultz has nurtured in Trenton. Our PAC is instrumental in achieving this and is not part of your regular dues. Please keep this in mind and consider making a generous voluntary contribution to the NJ Dental PAC with your dues payment (consider dedicating the revenue from just one procedure to it). The future of your profession is at stake, and, thus far, NJDA has been quite successful working on your behalf on many issues.

NJDA Trustee Report (Dr. Shah):
The trustees had discussion about a proposed NJDA education course for nonmember foreigners trained in US dental schools. There was general consensus that MOCDS has question about the appropriateness of NJDA hosting this course and Dr. Kukucka will express this sentiment in writing to NJDA leadership.

Council on Annual Session (Dr. Shah):

NJDA November 2011 :

A motion was made, seconded and unanimously ADOPTED by the Board (Vote #1 BT- 11-11-21) to appoint Dr. Gregory LaMorte as NJDA Secretary for the remainder of the 2011-2012 administrative year.

Dr. Barbara Rich reported that the succession of officers will begin with the position of Secretary rather than the position of Treasurer. Dr. Gregory LaMorte will run for the position of Treasurer for the administrative year 2012-2013 and the new officer will become the Secretary for the 2012-2013 year. Dr. Roshong will succeed to the position of Vice President

NJDA received a letter from Essex County Dental Society nominating Dr. Thomas Rossi as its Trustee and Dr. Renee Arace as its Alternate Trustee. A motion was made, seconded and unanimously ADOPTED by the Board (Vote #2 BT-11-11-22) to appoint Dr. Thomas Rossi as Essex's Trustee and Dr. Renee Arace as Essex's Alternate Trustee.

Be it resolved that the rules of the Board shall be amended to abolish the entire section entitled Annual Session to be replaced by the following:

2. One ticket to the President's event,
3. All other social events and activities and continuing education classes (spouse or guest will be billed for his/her welcome dinner meal after the conference).

The members of the Board of Trustees shall be complemented:

1. One ticket to the President's event (the student component trustee shall receive two tickets),
2. The welcome dinner (spouse or guest will be billed for his/her meal after the conference).

The chairperson of the Council on Annual Session and his/her spouse/guest shall be complemented:

1. Their hotel room* for up to three nights,
2. Two tickets to the President's event,
3. All social events and activities and continuing education classes.

The component members of the Council on Annual Session (including the appointed representatives of the NJDAA and NJDHA) shall be complemented:

1. A hotel room* for up to three nights provided that:
 - a. the member misses no more than two planning meetings, OR
 - b. receives an excused absence from the chair for any meeting not attended beyond the two allotted,AND
 - c. attends the corporate partner reception (if the council member does not attend the corporate partner reception he/she will not receive a complementary Thursday night stay), AND
 - d. performs all assigned tasks at the Dental Conference and Expo,

3. One ticket to any ticketed social event/activity.

NJDA Past-President's (excluding the immediate past president) shall be complemented:

1. One hotel room* for the night of the President's event, provided he/she attends the President's event and also attends the House of Delegates session if it

NJDA Consultants that meet with the Council for planning purposes and/or are asked to perform a specific task at the Dental Conference shall be complemented:

1. Hotel room(s)* as determined by the NJDA President and Council Chair,
2. Ticket(s) to the President's event and all other ticketed social events/activities as determined by the NJDA President and Council Chair.

Award recipients MAY be complemented:

1. A hotel room* for one night, the particular night to be determined by the NJDA

President based on when the award is being presented.

Invited guests and their spouses/guests shall be complemented hotel rooms* for up to three nights, all ticketed social events and activities, continuing education classes and the President's event.

In addition, the President may, with the advice of the Executive Director and the Conference Chairperson, select additional guests. A motion was made, seconded and unanimously ADOPTED by the Board (Vote #4 BT-11-11-24) to amend the entire section of the Rules of the Board entitled Annual Session as presented by the Council on Annual Session.

Ms. DeCotiis reported that Dr. Gautam Govitrikar from Middlesex has been very helpful in formulating ideas for the recruitment of dentists of Indian origins. A CE course is scheduled for February. An Immigration Attorney will speak at the course concerning different citizenship status. Dr. Richard Kahn, Drs. Michael & Bernadetta Messana and Dr. Dipika Shah were invited to attend a function at the Indian Association and spoke to the group about opportunities to partner with the NJDA. It was thought that at the January Board of Trustees meeting, we present them with a plaque honoring their ten year anniversary

Dr. Robert Giantomas reported that license renewal has expired. The Board stated that if hygienists received their injection permits prior to September 9th, they had to take a refresher course. Mr. Arthur Meisel mentioned that the three year lease on his vehicle is ending in December and he and Stan would be looking to enter into a new lease for the next term.

On Friday the event of the day will be a Street Fair and on Saturday, we will have a Hi-tec Vendor Fair. The speaker sub-committee is working on the line-up with Stuart Isler.

This year there will be no Exhibitor Prospectus printout. We are supplying a two gigabyte flash drive. Not only does this save us money, our artwork is also displayed and the exhibitors are thrilled. After the show, they can erase the flash drive and re-use it.

Ms. Barlow is working on developing this as a resort family weekend. There will be a Kids Kamp with land and water sports as well as adult activities. She is presently negotiating the contract for 2013; Ocean Place is very interested in working with us.

Dr. Dipika Shah stated that she felt that speakers coming in for the Annual Session should address specialty dentists as well as general dentists. It was reported that NJDA is talking about coordinating speakers and working on some ideas in an attempt to streamline speaker solicitation.

Council on Dental Education (Dr. Andricsak):
Council on Dental Education Meeting Wed, Nov 9, 2011
Continued discussion on non-accredited dental assisting programs...the NJDA wants to red flag these programs so applicants are aware they are not eligible to take the CDA exam without 3500 clinical hours in an office. Now applicants believe if they complete the course, they can automatically take the CDA exam. An applicant can take the exam with 2000 hours of clinical experience if she completed an accredited program. Having a CDA only allows the applicants to take the RDA exam. Generally the accredited programs run for 9 months to 1 year of training and these girls take these quick courses for a few weekends and assume they are qualified. It is very ambiguous information and needs to be clarified. There are 5 dental hygiene schools in the state and 6 accredited dental assisting programs. You can go to NJDA.org for the list. The NJDA runs courses for members at headquarters sometimes on Wed and sometimes Sat. The attendance is usually 20-50 members. There is a shortage of dental educators and the presenter must be a member. As of right now, the NJDA website allows online payments of dues and conventions but does not allow CE courses to be paid online.

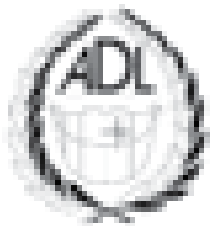
