MOCDS MEETING MINUTES JANUARY 6, 2015

The meeting was called to order by Dr. McTaggart at 7:05 p.m.

Motion was made to approve the minutes from the last meeting November 4, 2014, Dr. Albin first and Dr. Velazquez second the motion.

President's Report (Dr. McTaggart):

Happy Holidays to all!

Governor Christie signed the non-covered services benefit into law last month. This is a great victory for organized dentistry! Letters from insurance carriers are already being sent out to let providers know of the policy change.

We are getting great interest from sponsors for next year who are already partnering with NJDA. This hopefully will continue and allow greater access to vendors for our members.

I am working with NJDA to discuss recognition options for members to show our appreciation for their continued membership. Initial thoughts were recognition at 5, 10 and 20 years, since our membership is showing the greatest decline at the 5-10 year mark.

I am looking forward to hearing from NJDA President Dr. Roshong, Executive Director Art Meisel and Jim Shultz on January 13th.

Vice President's Report (Dr. Andricsak):

Dr Thomas Sinsack has graciously accepted the incoming officer position of recording secretary. Per our by laws, the 5 year term limits began in 2011-2012 term with Dr Kukucka presiding president. Therefore, in 2016-2017, during Dr Angowski's year as president, the new position holders will commence their term.

Executive Secretary's Report (Dr. Angowski):

All accounts are in good standing.

NJDA Trustee Report (Dr. Shah):

Here's my report including council on Annual Session.

The Board was asked to approve the nominations of Dr. Jessica R. Marinoff as Hudson's representative to the Council on Membership, replacing Dr. Sharon Stern and Dr. David Goldberg as Central's representative to the Council on Membership, replacing Dr. David Lipani.

A motion was made, seconded and unanimously ADOPTED by the Board (VOTE #1 BT-14-11-20) to approve the Consent Calendar in its entirety.

Dr. Bryon Roshong inquired from the Trustees regarding the progress being made by their component societies on the effort to retain non-renewals. Dr. Chenman (AC) reported that his component was working on a list of non-renewals.

Dr. Bryon Roshong announced that the House of Delegates approved the amended Budget to increase the funding of ADA Delegates/Alternates to 18 members. As the Board of Trustees needs to consider checks and balances, the component Trustee should make sure that there is an oral and written report back to the component.

Dr. Richard Kahn suggested that the members should be very cognizant in choosing plane fares when purchasing tickets for the ADA Annual Sessions. He reported that while signing checks, he noted that there is a difference of hundreds of dollars in the fares. He also feels that Delegates should be penalized if they do not attend the Pre-Annual Session Caucus.

Dr. Alan Rothstein felt each Trustee should go back to the component, reporting that NJDA can only afford a certain dollar amount and ask his/her component if it can create a line item in its Budget to support the ADA Delegate/Alternate.

It was reported the new computer system, Aptify, will be rolling out in New Jersey sometime during the Summer

Dr. Joe Krulewicz reported that Central Dental Society is concerned over non-owner dentists and how we are serving them and what value we give to them. He presented a motion to discuss a new membership category for non-owner dentists and a dues structure. Central would like to see a new dues level for just these people and wanted to ask if they should bring it to the Board of Trustees. It was felt that a marketing campaign should be set up to educate that category. It was suggested that the motion be referred to the Council on Membership. A request was made to call the question. A motion was made, seconded and unanimously ADOPTED (Vote 2 BT-14-11-21) to refer the Question on a new membership category for non-owner dentists and a dues structure to the Council on Membership.

Council on Dental Benefits – Ms. Mary Moskal

Ms. Mary Moskal reported on the many problems that currently exist due to the new Medicare prescribing rule that will take effect in June 2015, the lack of consistency and clarity emanating from CMS to ADA, and the problems that members have reported to NJDA. As an example, a prosthodontist received a rejection letter after trying to enroll in Medicare as a billing provider using the "other physician" category; CMS's response to this issue was a contradiction of all of the guidance provided to ADA/NJDA to date. Another problem surfaced with the Referring Provider Rule enacted some time ago. This rule does not apply to "doctor to doctor" referrals, but at least one oral surgeon reported that he was not being reimbursed for x-rays because the general dentist had not enrolled nor opted out of Medicare. Ms. Moskal is hoping to resolve these issues within the next few weeks. In the meantime, dentists have time to delay action on the Medicare enrollment/opt out decision since the Prescribing Rule does not take effect until next June.

MOCDS TRUSTEE MEETING MINUTES January 6, 2015

Communications – Ms. Nicole Fredrickson

Ms. Nicole Fredrickson reported that at the Council's next meeting it will be working with the components putting together an updated Continuing Education section which advertises component meetings and CE. There was a question whether or not component CE schedule updates could be put on the NJDA website. It was reported that components that provide Nicole with their meeting and CE dates will be added to the website.

It was reported that the Periodontists contacted Maureen for scheduling and it was felt that this information would be good for us to know. Dr. Barry Wolinsky stated he was in favor of a website calendar and would like to see the component newsletters on the website also. Newsletter editors of each component were provided with contact information for other newsletter editors to promote cross-component marketing.

Programs & Development – Ms. Maureen Barlow

The Legislature continues to look at changing NJ's Prescription Drug Monitoring Program (PDMP). To date, Twenty-one bills have been introduced with a number of fact-finding hearings. Presently, there is a 13% utilization rate of the PDMP and prescription drugs are the most abused drugs in America. Vicodin, OxyContin and oxycodone are the major gateway drugs into Heroin use. The NJDA is in a coalition with other prescriber groups to ensure that, while changes need to occur within the PDMP, that doctors still have the ability to treat their patients as they see fit.

Executive Director & Legal Counsel's Report – Mr. Arthur Meisel

Mr. Arthur Meisel reported that at its last public meeting, the State Board clarified that while registered dental assistants can perform, without hand instrumentation, a supra-gingival polishing using a rubber cup with pumice and a rotary slow speed hand piece, they cannot use prophylactic paste to conduct the procedure. The Board's concern was that if the prophylactic paste was used, it could be billed by the dentist as a prophylaxis. Mr. Meisel asked the NJDA Board whether or not he should bring this back to the State Board to be re-visited. A motion was made, seconded by the Board (Vote #3 BT-14-11-22) to have Mr. Arthur Meisel revisit this issue at the next State Board of Dentistry meeting. The motion was defeated.

Middlesex – Dr. Mitch Weiner

Dr. Mitch Weiner reported that Middlesex implemented a dental program with five (5) dental students whose home address was in Middlesex and paired them up with a mentor.

Monmouth-Ocean – Dr. Dipika Shah

Dr. Dipika Shah has three articles on group management she would like to email to the Board and ask the editor if we can have them published. She will follow up.

ADA Delegate (Dr. R. Isaacson):

ADA ANNUAL SESSION will take place in WASHINGTON DC

Council on Annual Session (Dr. Shah):

Annual Session. Maureen Barlow reported that Lorraine Sedor is designing and distributing News Briefs to Council on Annual Session members to disseminate to the components. We will also continue to utilize fax blasting as a means to communicate. Registration for Annual Session is open and we are almost sold out on exhibit space. All speaker honorariums are covered for this program. We continue to sell sponsorship for events. For the 2015 conference we are charging a \$25.00 conference pass. This Pass includes continental breakfasts both days, lunch and learn course credits, Table Clinics, an extensive attendee reception, Prizes awarded every hour the exhibit floor is

open and a \$25.00 gift card to be used with any exhibitor at the conference. Ms. Barlow reported that a number of new programs were introduced at the Business to Business Breakfast in October.

- Resources Day is a full day Open House here at NJDA focused on practice management tools for members dentists and their staff. The program will include continuing education as well as resources and a shredding truck. The tentative date is September 30, 2015.

- Two New Dentist Conferences will be scheduled in the fall as well. One in North Jersey and one in South Jersey.

- Bank of America will be hosting a program here at NJDA focused on starting or expanding a practice.

- We will be designing a Program Guide focusing on "the power of three". This guide will be mailed to all members and distributed at component meetings.

- Ms. Barlow has submitted four MPG (Membership Programs for Growth) grants with the ADA. The programs submitted will offset expenses for Resource Day, the Program Guides and two receptions at the Garden State Dental Conference & Expo including a Legislative Event and Employment Match program.

- Ms. Barlow plans to visit all components during the first quarter of the year to discuss Annual Session, the Program Guide, ADA webinars and the newly designed website calendar pages.

- We have received CERP (Continuing Education & Recognition Program) approval from the ADA for our courses and programs. NJDA was approved for 3 years.

Endorsed Business Associates

- Ms. Barlow thanked the Board for attending the Business to Business Breakfast; the next date is October 14, 2015.

- The Endorsed Business Associates (EBA) commitments are coming in. (moved from above)

Governmental & Public Affairs - Mr. James Schulz

Trustees made a suggestion regarding CE courses held during the NJDA annual meeting. In order to promote both doctor and staff attendance/participation, the classes held on Friday should be geared toward the entire dental team. This would allow the doctor to bring the staff to a useful course, and removes any objection by staff members on attending meetings over a weekend. This may help increase attendance for Annual meeting.

Committee on Membership/New Dentist (Dr. Kuckucka):

The council on membership met on November 20. The meeting was led by Art Meisel since Mary left NJDA employment. The main focus of the discussion was that Art wants to create more value for membership. He wants to get things like retail discounts, etc for being a member and wants suggestions from member dentists as to what to work on. (I suggested corporate discounts from cell phone providers like ATT). We also discussed the need to create a brochure highlighting the value of membership for non-owner dentists, as many new dentists are employees and they don't see the value in membership. Membership Numbers to Date

To date the total membership number is 4548. Up 1 from last year at this time. Active members are down by 45 from this time last year.

Mentor Program Update

The kick-off luncheon for Rutgers students is scheduled for January 28, 2015 from 1-2pm. The luncheon is for the 2nd & 3rd year students but the program is open to all students. A meeting to discuss the event details is scheduled for January 8, 2015 at 5pm.

Marketing Ideas

Art Meisel asked the Council to gather ideas for new discount programs and/or benefits NJDA can offer members.

Also discussed were providing more benefits for employee dentists. Dr. Marinoff discussed the idea of a component buddy system for new members attending component meetings.

An NJDA new marketing piece will include a Great West Life testimonial by a member dentist.

Strategic Promotional Incentive

The ADA Strategic Promotional Incentive (SPI) offers a one-time 50% discount for non-members 5-10 years out of dental school. The ADA has not begun to market this program yet, it will likely occur in late December. The NJDA will market the program at the same time. All council representatives will be sent their component eligibility list at that time.

Next Meeting Dates

Trustees suggested to provide incentive and value for non owner dentist to join the organized dentistry by highlighting what the NJDA offers to new non- owner members such as CE courses and legal consultations and networking and so on.

Dr. Richard Isaacson suggested that ADA should offer a Credit Card with substantial benefits for active members/ new graduates. Benefits such as, 2% cash back and other incentives, car rental discounts, hotel/ travel discounts. ADA & State/ Local membership dues then be deducted monthly from the credit card.

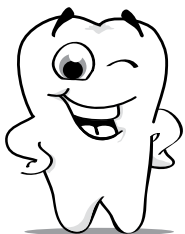
