The meeting was called to order by Dr. Furlong at 7:00 p.m.

Approval of the minutes from last meeting:

President's Report (Dr. Furlong):

Our new member meeting on April 8 was a big success, with 20 non-members out of 85 total people in attendance that evening. I want to thank Rob McTaggart and our new member subcommittee, as well as everyone who contacted non-members to come to our meeting. The M-OCDS will be working with the NJDA to follow-up with those who attended our meeting, and to fine tune recruitment efforts in the future.

In addition I spoke with Tricia and we agreed first contact of these

I have drafted a letter based on the NJDA information sent to new members regarding advantages to organized dentistry etc. I would like these non members to be included on the eblast list for MOCDS. If they show up at meetings as non members we will collect non member fees to cover the dinner. NJDA Trustee Report (Dr. Shah):

Dr. Paul Lawyer, on behalf of DDS, made a motion to add a line to the NJDA Dues Form as a voluntary contribution. It was defeated by 7 to 13 vote. Some additional discussion ensued. A motion was made, seconded and unanimously ADOPTED by the Board (Vote #2 BT-14-4-8) to ask the Trustees to go back to their respective components and encourage its members to make a contribution to Dental Lifeline. Dr. Vitale made a motion ADOPTED by the Board (Vote #3 BT-14-4-9) to have the NJDA make an immediate contribution of \$2500. to Dental Lifeline. The motion was passed with two nays.

The Committee on Continuing Education was charged with looking into restructuring the Annual Session. On behalf of the Committee, Dr. Tom Rossi proposed that in 2015, , the meeting of the House of Delegates and the President's Dinner Dance be separated from the Annual Session. It was suggested that the President's Dinner Dance be held in the area of the component to which the President belongs and the House of Delegates can be held at the Pines in Edison as it is for the Semi-Annual Session in November

Separating the House of Delegates meeting from Annual Session requires a Bylaws change. A motion was made, seconded and unanimously ADOPTED by the Board (Vote #5 BT-14-4-11) to allow the CE Committee to proceed with the process of separating Annual Session from the House of Delegates meeting and President's Dinner Dance and to propose amendments to the NJDA Bylaws to accomplish that purpose.

COMMUNICATION – Ms. Nicole Fredrickson is helping DDS program as requested and there are lots of ongoing improvements on website including changes for membership benefits for new dentists, CE courses from components, ability to "Fill able forms" etc.

Dr. Bryon Roshong, Chair of the Committee on Rules & Order, reported that the Committee approved the Agenda and proposed dates for the upcoming year. Our first

MOCDS TRUSTEE MEETING MINUTES May 6, 2014

BOT meeting after the Reorganization meeting in June will be held on Wednesday, July 23, 2014. That meeting is a combined meeting with the ADA Delegates and Alternate Delegates as well as hosting the two ADA President-Elect candidates.

Dr. Walter Chinoy reported that the April 1, 2014 date has passed and we have received no additional nominations to the officers slate, therefore, those officers nominated are duly elected. Congratulation to Dr. Alan Rothstein as NJDA Secretary. To date, the only resolution we have is changing the mailing of the Budget to 30 days prior to the Semi-Annual Session rather than 60 days.

The Board went into Executive Session. For the public record, the contract with the Executive Director was renewed for five years, effective January 1, 2015.

Mr. Arthur Meisel presented a brief litigation update and thanked the Board for its confidence in him by renewing his contract.

Mr. Paul Lawyer from Southern expressed the need for volunteer dentists for the DDS Dental Lifeline. He reported that both general dentists and specialists are needed.

Mr. Richard Cohen and Ms. Amy MacFadyen of Eisner Amper, the NJDA Accounting firm, reported on its audit. They briefly reviewed the NJDA financial statement and reported that there were no disagreements with management, no difficulties and no risks to the organization. A motion was made, seconded and unanimously ADOPTED by the Board (Vote #4 BT-14-4-10) to accept the audit report, tax return and IRS Form 990.

Dr. Melvin Feldman, an orthodontist and member of Bergen County Dental Society as well as the father of Dr. Cecile Feldman, Dean of Rutgers School of Dental Medicine addressed the Board. Dr. Feldman reported on his past history with the peer review of specialists. He asked to make a change in the peer review Procedure Manual. After a Peer Review has occurred and an appeal is filed, he would like the appeal to be reviewed by the Specialty Association. However, the Specialty Association is not part of our Peer Review mechanism internally. He was explained that specialty should make sure that they have their member on each component peer review committee.

New Business:

It was reported that the Executive Director for the NJDA, Art Meisel, received a new contract for the next 5 years.

We need to update the by-laws in August researching all old amendments. Drs. Kukucka and Albin will be leading this.

All members need to review all of their PAC donations and should increase if they feel necessary. Please contact Dr. Velasquez to donate.

ALERT: HIPAA Security Risk Assessment Tool Released

Dentists who are HIPAA covered entities are aware that the HIPAA Security Rule requires that they conduct a periodic Security Risk Assessment (SRA) of the practice. If you have not yet completed the SRA because you're not sure where to start, help is now available. The U.S. Department of Health and Human Services (HHS) has just released an SRA tool that, according to the press release, "allows practices to conduct and document a risk assessment in a thorough and organized manner at their own pace."



ALERT: Windows XP Systems - Possible Security Risk

If your office uses a Windows XP OS, you are probably aware that Microsoft will no longer support the system after April 8, 2014. That means there will be no more security fixes, software updates or technical support, although Microsoft will still provide some anti-virus software until July 2015. How much of a problem that will become in light of the HIPAA security rule depends on who you ask.



ALERT: OSHA Revised Hazard Communication Compliance Standard

To ensure employee safety, by December 1, 2013, employers are required to develop and make available, in an understandable format, information about the identities and hazards of chemicals in the workplace. Dentists who subscribe to ADA's OSHA compliance manual should have received an update.



ALERT: N.J. Requires New Prescription Blanks to Fight Fraud

Under a newly-adopted regulation by the Division of Consumer Affairs ("Division"), prescriptions issued by New Jersey dentists and other prescribers on or after August 19, 2014 must be written on prescription blank forms containing new security measures designed to fight fraud. Existing prescription blanks will continue to be valid, but only for prescriptions written on or before August 18, 2014. The Division currently is in the process of approving vendors to print the new forms, which can be used by prescribers immediately.

ALERT: Placement of Anesthetic Agents Under General Supervision by Dental Hygienists

Although local anesthesia can be administered only under direct supervision by licensed Dental Hygienists to whom a permit has been issued, the New Jersey State Board of Dentistry has clarified that all dental hygienists licensed in this State are permitted to apply topical and sulcular anesthetic agents under general supervision.

ALERT: In-House Discount Dental Plans

At its recent public meeting, the State Board of Dentistry restated its previous position on dentists offering an "in-house" discount dental plan. The Board determined that a dentist may offer a plan to patients, but that the plan can't be limited to those without dental insurance. If the patient has dental plan coverage, the discounted fee must be reflected on the claim form submitted to the dental plan. As a reminder, discount dental plans are not insurance so the coordination of benefits rule does not apply. For more information, contact Arthur Meisel - direct dial 732-422-2730.

ALERT: Are your state and federal labor, wage, safety and antidiscrimination posters up-to-date?

As an employer, you must display certain notices and posters advising your employees of their rights under state and federal law. You do not have to pay for these posters. ALERT: OSHA Inspections

When OSHA receives a complaint, it conducts an investigation and, if warranted, imposes monetary penalties. All dental practice owners should be sure that there is a readily accessible written Exposure Control Plan, that it is reviewed at least annually with employee input to determine if revisions should be made, that new employees receive appropriate training and that all affected employees receive annual training. ALERT: HHS Issues Spanish Version of Model Privacy Practices:

A Spanish version of the Model Notices of Privacy Practices (NPP) has been issued by the U.S. Department of Health and Human Services Office for Civil Rights (OCR) and Office for the National Coordinator for Health Information Technology (ONC). HHS has provided separate models for health plans and health care practitioners to help them better serve their Spanish-speaking patients and plan members. ALERT: Patient Record Requirement

The New Jersey State Board of Dentistry requires that all treatment records contain a "diagnosis and a treatment plan, which shall also include the material treatment risks and clinically acceptable alternatives, and costs relative to the treatment that is recommended and/or rendered."
