

## M-OCDS Sponsorship Options 2023-2024

### I. **Exclusive Platinum Dinner Meeting Sponsorship**

- a. This is the highest level of sponsorship offered by the M-OCDS.
- b. M-OCDS is permitted to invite only NON-COMPETING companies in unrelated industries to the dinner meetings. NO COMPETITORS WITHIN THE SAME INDUSTRY.
- c. This entitles your company to be an exhibitor at ALL of our general membership dinner meetings. There are five (5) meetings each year. You will have a table in the registration area inside the banquet room, the opportunity to promote your services and/or products during our registration and cocktail hour, name recognition as a financial sponsor for the monthly meetings, dinner for your representatives (max of FOUR representatives) with seating among the meeting participants, and awarding of a door prize in your name by your representative. **\*Banks and Financial Institutions other than Bank of America may not offer or discuss practice acquisition or start-up financing.**
- d. Includes company name in ALL e-blasts sent to members regarding general membership dinner meetings.
- e. Returning exclusive sponsors have the right of first refusal to maintain their exclusive sponsorship for three years running provided they inform M-CODS of their desire to maintain the exclusive sponsorship by June 15<sup>th</sup> of each year.
- f. **Cost: \$2,500 total**

### II. **Gold Dinner Meeting Sponsorship**

- a. This entitles your company to be an exhibitor at ALL of our general membership dinner meetings. There are five (5) meetings each year.
- b. You will have a table in the registration area inside the banquet room, the opportunity to promote your services and/or products during our registration and cocktail hour, name recognition as a financial sponsor for the monthly meetings, dinner for your representatives (max of TWO representatives) with seating among the meeting participants, and awarding of a door prize in your name by your representative. **\*Banks and Financial Institutions other than Bank of America may not offer or discuss practice acquisition or start-up financing.**
- c. Includes company name in ALL e-blasts sent to members regarding general membership dinner meetings.
- d. **Cost: \$1,600 total**

### III. **Bronze Dinner Meeting Sponsor**

- a. This entitles your company to be an exhibitor at our general membership dinner meetings. There are five (5) meetings each year. This sponsorship entitles your company to be at ONE dinner meeting. There is no limit to how many meetings you can attend, but if you are interested in sponsoring multiple meetings, the GOLD package will allow you be at each of our five dinner meetings and save you \$275.
- b. You will have a table in the registration area inside the banquet room, the opportunity to promote your services and/or products during our registration and cocktail hour, name recognition as a financial sponsor for the monthly meetings, dinner for your representatives (max of TWO representatives) with seating among the meeting participants, and awarding of a door prize in your name by your representative. **\*Banks and Financial Institutions other than Bank of America may not offer or discuss practice acquisition or start-up financing.**
