## MOCDS Celebrates Children's Dental Health Month!


Children's Dental Health Fair was held at the Monmouth Mall and Ocean County Mall on February 2, 2018

The meeting was called to order by Dr. Safari at 6:34 p.m.

Approval of the minutes from last meeting:

Motion was proposed to approve the minutes from the last two trustees' meetings. January 2, 2018 & November 7, 2017. Dr. Rick Isaacson first and Dr. McTaggart second the motion.

President's Report (Dr. Safari):

OLD BUSINESS:

Art Meisel reviewed AMT. Members are signing up for the insur-

ance plans and the numbers show a savings. It is also noted that even when members don't have a cost savings, often they are receiving an increase in benefits. AMT is a member benefit. Please remind all members and non-members and also consider for your office.

All eligible employees must get life insurance (paid my doctor) to participate in the AMT plan

Dr. Vitale update on headquarters renovation.

A drawing was presented as to changes that could be made for the renovation. It was approved to get bids from contractors. When bids are in, then we will know what cost that would be associated with such a project. Nothing will be approved without approval from all components.

- Recommendation was made to have a dentist familiar with building construction be on the committee that aids in construction ideas/planning.

SOCIAL MEDIA- Maureen reviewed the action plan. Each component will have a rep. Our champion of action leader is Marina Sereda. The final plan will be presented at our annual session.

Succession plan: Surveys and assessments were given to all trustees. Info will be collected and reviewed. The plan will go back to committee for review and will discuss findings at the March meeting. NEW BUSINESS:

Nominations Committee: Dr. DiVincenzo discussed the process. If someone wants to run they need to submit names to the committee. Dr. Peter DeScisio will be the next secretary as he was unopposed. IOURNAL:

Discussion was had as to whether or not we should keep the journal. Is it cost effective? Well received? An amendment was made that the journal SHALL be published to MAY be published.

TREASURER: Dr Weiner gave a report. Membership income is down and we have cut many expenses. We need to be more creative in recruiting members. Reminder for ADA annual session delegates that There is a flat amount that will get distributed to ADA delegates and alternates. Components have the option to cover short falls.

### COMMITTEES:

Membership: At the end of 2017, we are down to below 50% of market share.

New Dentist: events goring well. Last one at brewery.

Annual Session: all on track. 50% tables sold. Please be present and spread the word.

Peer Review- 52 cases this year. MOCDS only had an increase in 1. Remember this is a member benefit- although nonmembers can participate.

Dental Benefits: AETNA urging EFT but you can OPT OUT. BCBS DELTA BWs 1x Government Affairs.

Governor Murphy sworn in January. A detailed memorandum was given to the Murphy transition team. We keyed in on oral health needs and our issues are known. Dental director, mandating dental exam before entering school, gave info on our OPIOID reduction initiatives and DDS program. NJ received a \$45,000 state government & public affairs grant from ADA. (SPA money) It is a 6-month funding. We submitted for 24 months and will need to reapply every 6 months for additional allocations. Money will be for hiring consultants. NJDA member Jeff Van Drew will be running for Congress. We have formed a MILLENIUM CLUB with Dr Perle & Dr Cory as the chairs. Our goal is to raise \$1000 from 100 dentists. This will be outside of NJPAC. Please consider this.

Presidents Report. VITALE Puerto Rico thanked us for our donation. Drug Free Nj will sponsor an opioid course at the annual session. Dr Vitale continues to meet with the carpenter's union to consider a relationship and discount plan for their members. Dr Vitale in communications with United Way to attempt to get help for Dental Lifeline

Dr. James A. O'Malley, 86, of Little Silver, NJ and formerly Vero Beach, FL, passed away peacefully on October 24th, at home with his family. He had courageously battled pulmonary fibrosis for over 20 years.

Dr. O'Malley graduated from Xavier High School, New York City, College of the Holy Cross, Worcester, MA and the University of Pennsylvania School of Dental Medicine. He served as a Captain in the United States Air Force.



Dr. O'Malley lived in Allenhurst, NJ for the majority of his life, where he had a dental practice, and served on the Commission for 14 years, including four as Mayor. He was the past President of the Monmouth Ocean County Dental Society in 1971 and a member of the Asbury Park Kiwanis.

Dr. Samuel Denton Moore, DDS (ret.), 90, passed away peacefully with loved ones on January 13, 2018 in Brick, NJ.


Sam grew up mostly in Farmingdale and Buffalo, NY. College football allstar 'center' tackle (Clemson/Catawba) and early wannabe coach. Fortuitously interrupted by US Army service as a WWII glider paratrooper in the Japan Occupation Forces. He served in the 11th Airborne Division - 674th Field Ar-



tillery Battalion. Then via the GI Bill, he went on to NYU and finally Temple University in Philly for dental school.

A longtime area dentist (1957-1994), his first office was in Lakewood. He was instrumental in the establishment of the dental department at Paul Kimball Hospital and was a partner in developing an office building on E. County Line Rd. where he practiced for 30+ plus years. He would often take no pay or barter for his services from the less well-off. Sam was a longtime member of both the American and NJ Dental Associations and Psi Omega fraternity.

Dr. Frank L. Greiner, DMD, 85, of Little Egg Harbor Twp., NJ passed away on Friday February 9, 2018. He attended Temple University as a pre-Theology student and served as Minister to the Lumberton and Smithville Methodist Churches. Frank also graduated from Guilford College in Greensboro, NC as a Psychology major and also graduated from University of Penn. Dental School with a DMD and also completed a 2 year course on Orthodon-



tic Residency. He had an Orthodontic practice in Willingsboro, NJ as well as in Manahawkin, NJ. Frank also taught high school Chemistry and English in public school in Bordentown, NJ.


