# From the President

Two months ago, our Society was called upon to throw a lifeline to a charity that does just that for our most vulnerable citizens. The



Dental Lifeline Network (DLN) has provided 8,959 New Jerseyans with \$24.1 million in care since 1988, but this year budget constraints almost cut the cord on these elderly and medically fragile patients with an inability to afford necessary dental care.

Dr. John Feeney, Chair of Donated Dental Services informed the Board of Trustees in August of a \$40,000 deficit that threatened to end the program altogether in New Jersey. He cited a decrease in corporate charitable contributions and a lack of governmental assistance (which is present in other states) against an increase in administrative costs. The DLN had one loyal full-time administrator, Shanda Bell, whose position was reduced to just 12 hours per week. This was grossly inadequate to run a state-wide charity.

Our Board, made up of many who donate their time to serve DLN patients, moved quickly from discussion to a vote to mobilize funds. We passed a motion to donate \$999 immediately to the DLN. As of today, we've learned that several other components rose to the occasion. Together with the efforts of Jim Schultz in Trenton, sufficient funds were raised to restore Shanda to 20 hours per week to help get more patients into the chairs of New Jersey's most benevolent providers.

I chose to feature this story because we mostly speak about what M-OCDS is doing for its members. But, an equal part of our mission is "to encourage the improvement of the health of the public." # M-OCDS TRUSTEES MEETING MINUTES

The meeting was called to order by Dr. Sniscak at 7:02 p.m.

Approval of the minutes from last meeting:

Motion was proposed to approve the minutes from the last meeting, August 7, 2018 by Dr. Richard Isaacson.

President's Report (Dr. Sniscak):

We have started our 2018-19 year off with a bang. The Networking Event was a tre-mendous success drawing more members than expected and coming in under budget (See Dinner Committee report for details). The goal was to strengthen relationships between colleagues and create a welcoming environment for new members. Roughly

40% of the sixty attendees were new dentists (<10 years from graduation). Classmates were reunited, former residents reconnected with attending faculty, group practices introduced new associates, and lots of business was discussed. Our sponsor, Seth Arndt from Tomoro, mentioned that the event exceeded his expectations in terms of productive conversations with current and prospective clients. He presented M-OCDS with a \$1200 sponsorship check which covered half of the total cost and looks forward to doing similar events in the future.

Our first dinner Meeting is October 9th. The topic is Digital Impressioning and it's sponsored by Asteto. Marc Daichman, owner of Asteto, just informed me that the scheduled lecturer, Alec Ganci is not available. He is providing "another well qualified dentist to present, his name is Dr Seth Wallerstein." I am working on updating the state board with the new speaker's information. Newark Dental and 3M reps will be there with at least one intraoral scanner to provide and interactive experience. As we did last year, CSAV will be there for the first hour to set up the AV equipment to ensure smooth operation.

Treasurer's Report (Dr. Guerrasio): All accounts are in good standing.

Secretary's Report (Dr. LaFalce):

The MS Office subscription (MS Word, Excel, etc) for the laptop expired. I renewed the package. Cost \$74.63 (including tax) for a one-year subscription which automatically renews annually.

NJDA Trustee Report (Dr. Velazquez): BOT 9/12/18 report:

UNDER THE NEW PRESIDENT ROTHSTEIN, ALL COMMITTEE & COUNCIL REPORTS ARE SUBMITTED IN ADVANCE AND WILL BE INCLUDED IN THE MINUTES, WHICH WILL BE DISTRIBUTED UPON RECEIPT. NOTE ONLY ADDI-TIONS TO REPORTS ARE DISCUSSED AT THE BOT.

The budget meeting was before the BOT. The main message is that membership is declining and we need to work on retention & recruitment of new members. We can not depend on sponsors & vendors for the success of our organization.

Dental Lifeline Network needs our support. Asking for NJDA to donate \$2500. We are asking every component and individual to donate. Central & MOCDS have donated. We also need volunteers for DLN. Line item to be created on the dues statement for \$50 suggested donation below the line. Motion passed.

 Art Meisel- He presented an update on the Aetna case. He reviewed conflict of interest & organization of rules for the board whistle blower policy- we do not tolerate discrimination

Lawsuit with us representing overpayment recovery.

\*We filed with superior court in Somerset county supporting summary judgment - lawsuit

for 5 member dentists against Aetna regarding alleged over payment. HE will keep us posted when additional info is received.

Brief filed in appellate division against DOBI. DOBI adopted regulation to implement statute HICAPA (health claim auth & payment act) adopted 2006. Now finally making regulations. We are challenging regs that statute doesn't apply to dentistry. Ex. Overpayment recovery could be a problem. We are waiting and he will keep us posted.

- 3) Financials review- Dr Ghisalberti. Switching to RBC for finances to gain some interest on reserve money.
- 4) Rothstein- Advised us to accept the budget as presented & pass to HOD. Motion passed. The budget will be presented at HOD.

4) Membership- 3919 last May (including life retired etc) this May 3878 (down 1%)

545 NON renew. Less non-renew than last year.

Annamarie has been doing a great job. And keeping up with numbers.

This is not solely responsibility of the council but also the entire board.

ADA has a promotion initiative to target nonmembers. Last year 8 joined. This year there are 39 so it seems to be effective.

They will be promoting half dues for the remainder of the calendar year. & then there is the benefit of AMT.

New dentist- they are dropping off at the 5th year when they go to full dues. This is the key for our growth.

Strategy and recruitment plan is being solidified for ideas for membership. Every component charged with getting 6 new members. \*\*

# **MOCDS TRUSTEE MEETING MINUTES October 2, 2018**

The ADA Annual Dental Meeting is scheduled for October 18-22, 2018, in Honolulu, Ha-

On September 29, 2018, the Fourth District held a pre-meeting caucus in Wilmington, Del. The purpose of this meeting is to give all delegates and alternate delegate a preliminary review of all resolutions to be considered at the ADA House of Delegates. The resolutions which are likely to receive the most discussions are as follows:

A. Budget, Business, Membership & Administrative Matters

1. (#36) Special Assessment: The HOD developed the Ask A Dentist initiative two

- years ago (Res 67#). It was funded for the past two years by ADA reserves This year a resolution has been proposed to fund the program with a \$58.00 assessment to the membership. (BOT – Yes)
- 2. (#35) Dues Increase- A \$22.00 dues increase has been proposed to reduce the \$600,000 budget deficit. The \$22.00 assessment will not completely eliminate the deficit. The remaining portion will be covered from reserves.

  3. A second building was purchased in Washington, D.C. close to the Senate.
- 4. The ADA reserves continue to shrink. At this point our total reserves are less than 50% of our annual operating budget.
- 5. Executive Director Compensation
  - a. The executive director base pay is currently \$575,250.00. She also received a bonus of 4% (\$22,340.10) in March 2018. She also receives fringe benefits amounting to \$15,000.
- 6. Budget Information
  - a. Dues revenue is not anticipated to increase. It may slightly decrease as membership declines
  - b. Total operating budget projected is \$133,754.00 c. Net Income <\$2,240>
- 7. Total ADA Staff is 430. This is an increase of 3 staff members from 2017.
- 8. The BOT voted to approve the 2019 budget.
- B. Dental Benefits, Practice and Related Matters
- 1. (#3) Direct to Consumer Dental Labs BOT-No 2. (#19) Opioid Statement
- The ADA supports statuary limits of no greater than 7 days for acute pain.

(#25) Clinical Data Registry

Investigating developing a clinical dental registry to which would be applied evidence based practices BOT-No

4. Dental Benefits in Medicare

The topic of incorporating dental benefits within the Medicare System is being examined by the ADA. This initiative is being driven primarily by the AARP. The board voted to refer this resolution.

- C. Dental Education Science and Related Matters

1. Dental Hygiene License Portability
The resolution supports the ability for RDH's licensed in any state to acquire licensure in another state without additional examination procedures

- 2. National Commission on Recognition of Dental Specialties and Certifying Board. This resolution encourages all state dental boards to recognize the newly created NCRDSCB BOT-Yes.
- 3. Dental Licensure Comprehensive Policy

A resolution has been proposed which describes policy provisions for state licensing boards regarding dental licenses.

- D. Legislation, Health, Governance and Related Matters
  1. Election Procedures Defined
  2. Campaigning Protocols for President Elect and 2nd V.P. Defined

New Business:

Dr. Rick Isaacson brought up the fact that some dental practices in NJ may be owned by "dental service organizations" instead of by dentists. We should ask Art or Jim to look into the legality of this because they are actual owned by investors/venture capitalists. We should take action now so that we don't have an influx of large, corporately owned dental offices taking over in NJ.

Council on Dental Benefits (Dr. Sirota):

The Council on Dental Benefits met on September 5. The next scheduled meeting is Nov. 7 and I cannot attend. Dr. Keith Libou, Chief clinical Officer for Delta Dental NJ is scheduled to join us. We have been asked to submit questions and topics to the council by October 20. Some other topics that we discussed are:

Aetna Bulletin: Discussed post and core codes (2950, 2954), and change to claim review policy by carrier to require pre-op and post-op films (photos or radiographs) to make a benefit determination. New Aetna claim review policy changes effective 9-18-2018.

Guardian Policy – Frequency of Perio Scaling/Root Planing: Discussed code 4346 – frequency issue; will only be paid every 24 months. Increased requests for clinical supporting documentation to re-establish perio patients. Discussed the requirement to document medi-

cal necessity for perio maintenance status
Delta Dentalytics/Recredentialing: Recredentialing forms, surveys and addendum to contracts have been mailed out.

EFT MetLife Model: The MetLife EFT model was discussed. If anyone has input or experience with Metlife's EFT program the council would like to know about your experience before proposing to the ADA

Council on Membership (Dr. McTaggart):

Please add new members listed below to constant contact so they can be notified of upcoming dinner meetings. I have had email contact with some of them already and will reach out to the rest next week. We had a meeting Monday at NJDA and discussed the multiple contacts needed to communicate with members under 10 years out of dental school and then more seasoned members and their preferred mode of communication. 
