The meeting was called to order by Dr. Matthew Sones at 7:03 PM. The meeting was held via ZOOM video conferencing.

We do have a Quorum.

Approval of the minutes from last meeting:

Motion was made to approve the minutes of the prior meeting was made by Dr. Albin and seconded by Dr. Friedman. All approved.

President's Report (Dr. Sones):

We have a great speaker lined up for next week's dinner meeting - Dr. Jonathan Mendia from Advanced Dental Anesthesia Services. He will be providing essential information with respect to safe sedation practices in dental offices and also reviewing basic dental emergencies. On April 18th, we have Dr. Alexander Volchonok providing new research and case studies regarding modern periodontal concepts that every dentist should know.

Vice President's Report (Dr. Soliman):

I am currently working to finalize next year's schedule for the association as well as update all of our Trustees and committee members. The Budget has also been started and awaiting information from our CPA to present to our Trustees at the next meeting.

Dr. Akriti Gupta has formally been nominated as a candidate for next year's Secretary position and will be announced at our next dinner meeting.

Discussed pros and cons of returning to in-person Trustees meetings vs remaining virtual.

One of the major goals for next year is to engage more new members

and members who are willing to step up to Committee and Chair positions, as we have some Trustees who have expressed interest in scaling back and some that are reaching their term limits.

Treasurer's Report (Dr. Nebblett):

\$2000 was donated to NJDA towards the Building Capital Campaign. This was the fourth out of five installment payments.

Secretary's Report (Dr. Seto): No report.

NJDA Trustee Report (Dr. Furlong):

NJDA has a new CEO Reva Brennan and a new legal firm. NJDA is currently interviewing for a Concierge and a Public Affairs Coordinator. There is no longer a Dental Benefits staff member, since it was determined that there were very few inquiries by NJDA members. Inquiries will now be fielded to another staff member or the ADA website. Former NJDA employee B. Smith recently passed away (she was receiving employee benefits as part of her contract from many years ago).

There has been clarification of NJDA constitution and bylaws, and updates will be presented at the next NJDA HOD meeting in June. Notes from meetings in executive session are only to be shared with Trustees and Alternate Trustees, and will be kept in confidence for 3 years.

Dental Lifeline Network needs volunteers in Ocean County. WE SHOULD CHOOSE SOMEONE TO REPRESENT DLN AT EACH DINNER MEETING WHO CAN ENCOURAGE MEMBERS TO VOLUNTEER AND ANSWER QUESTIONS.

VISIT THE NJDA WEBSITE AND CHECK OUT THE NJDA PERKS PAGE. NJDA no longer has "endorsed partners" and now companies that offer an exclusive discount/benefit for NJDA members are included. Reps from Best Card, Tempmee, Bell Insurance, Epstein Practice Transitions met with us via zoom. Dental benefits-Enhanced CDT codes have been a topic of discussion at the ADA. Thus far it seems that they will create problems with little to no benefit for dentists. They will likely increase costs because changes in software will be necessary. A motion was made at the meeting 3/8 and NJDA board of trustees unanimously opposed the ADA enhanced CDT codes, and it will be brought up to the ADA 4th district caucus in September. This will be discussed at the June 7 House of Delegates meeting. You can also visit the NJDA WEBSITE-there is a link to leave your opinion about this.

NJDPAC Golf outing will be April 14, and more events to follow in the upcoming months.

The March dues bill with the local component letters will be sent in the beginning of next month. 4 components submitted updates to the letter. The remaining 8 components letters will be sent out from the component president. NJDA Member Resource Review: Several website pages were reviewed with the Council.

NJDA LICENSURE REQUIREMENTS SERIES

2023

The NJDA has designed this Series to make the New Jersey State mandated continuing education courses convenient and easily accessible at a low price. Each mandated course is offered VIRTUALLY three (3) times in 2023 (from January through September). Each course is scheduled on different days/times to work around your busy schedule.

FOR DENTISTS ONLY

NEW Upcoming Requirements for the November 2021- October 2023 Licensure Period

The New Jersey State Board of Dentistry requires the mandatory completion of forty (40) hours of continuing education for license renewal, which takes place every two years. For registration renewal beginning on November 1, 2021, the following 10 hours must be completed as part of the 40 required hours.

- One Hour in Prescription Opioid Drugs
- Two Hours in Preventing and Controlling Infectious Diseases
- Three Hours of Pharmacology and Internal Medicine
- One Hour in Professional Ethics and NJ Law Concerning the Practice of Dentistry
- Three Hours with Practical Hands-On Certification for CPR

PLEASE NOTE: CPR is **NOT** included in this series but we offer a convenient solution for dentists and their staff available on NJDA.org

- Courses are offered monthly at NJDA Headquarters
- Blended Learning Courses are offered monthly- complete the lecture and testing requirements online followed by completion of a hands-on testing at NJDA Headquarters
- Schedule a Private Program at your practice (minimum 6 attendees required) for the same low member price!
- Merge with another practice to offer CPR near your location
- Hispanic Speaking program available

Although HIPAA Compliance is regulated by the Department of Health and Human Services (HHS) and enforced by the Office for Civil Rights (OCR) it is NOT A LICENSURE REQUIREMENT. Practitioners are, however, required to be updated. The NJDA has elected to add this program into our Licensure Requirement Series offerings.



MOCDS Celebrates Children's Dental Health Month 2023! "Brush, Floss, Smile!"

One of the most challenging obstacles we face on our quest for optimal oral health in children is promoting good home care habits. The month of February affords an opportunity to strike up our typical oral hygiene conversation and add a bit of a fun twist to our script. One source of "fun" is our annual poster contest which was open to all member dentists to promote within their practices.
