The meeting was called to order by Dr. Carmela LaFalce at 7:00PM. The meeting was held via ZOOM video conferencing due to circumstances surrounding COVID-19.

Approval of the minutes from last meeting:

The proposed budget was approved unanimously and will be presented for adoption at the November 17th HOD meeting.

- Medicare part B proposal to include dental. The proposal from ADA is to create a plan which would be good for everyone separately from part B; part "T". Including dental within part B has some potential negative consequences for dental moving forward. There is a "call to action" which we have promoted within our component over social media.

- Peer review training date is November 3rd; training is required 1 time per 3 years. It will be held as a virtual meeting.

A. Disallow Legislation:

B. Medicare Benefit in Dentistry:

Jim Schulz updated the Council on the current status of a proposed Medicare benefit in Dentistry

The U.S. Congress advanced a budget resolution which included a provision to expand the Medicare program to include dental benefits. The ADA believes an expansion of benefits within the current Part B structure of Medicare would not adequately meet the needs of our dentists and Medicare patients.

A 10-minute video was shown which explained why the NJDA and ADA oppose the inclusion of a dental benefit in Medicare part B.

A. Horizon FEP

Horizon Federal Employee Program is no longer processing payments to dental providers via paper check. The FEP automatically issues a SUA payment, which is a virtual credit card. Dental providers have an option to opt out of SUA and register with EFT as an alternate form of payment.

Great News is our 4th District delegate and ADA trustee Dr. George Shepley, D.D.S. got elected as upcoming president of ADA. - · Multiple alternative virtual CE programs available




