The meeting was called to order by Dr. Guerrasio- Safari at 7:01 PM. The meeting was held via ZOOM video conferencing due to circumstances surrounding COVID-19.

We do have a quorum.

Approval of the minutes from last meeting:

A motion was proposed to approve the minutes from the last trustee meeting on October 6, 2020 by Dr. J-Bruno, 2nd by Dr. Isaacson. A call to vote was made and approval of the minutes passed.

President's Report (Dr. GUERRASIO-SAFARI):

Happy New Year!

I hope that 2021 will be a year of health and happiness for all. We should be very proud of the work that we have accomplished as a society in 2020, and I look forward to what this year will bring.

- Our November Zoom meeting was very well attended, with 81 members registered.

- In December I attended a President's meeting which reaffirmed their efforts in getting the vaccine to dental practitioners/staff in the 1A category. It is imperative that the message be available via all forms of communication (ie. Email blasts, Facebook, Instagram and word of mouth). The NJDA set up an excellent resource page with the locations of vaccine sites as they become available. Our messaging needs to stress the following items: (Carmela LaFalce was in attendance for this Zoom meeting)

o NJ is getting less vaccine than originally promised and counties that are being hit the hardest will have accelerated access to the vaccine (Essex, Hudson, and Bergen). Each state has its own distribution plan and vaccine quantity allocated to them.

o The release of the Moderna vaccine has helped with the deficit

o The state has set up 6 mega-sites throughout the state to vaccinate individuals and set up scheduling.

- If there are any issues with access to vaccination please let the NJDA leadership know, as all dental staff should have the ability to receive the vaccine

- Our next Zoom meeting is with the NJDA leadership on Tuesday, January 12th. This is an excellent opportunity to hear from our leadership regarding the strides that they have made on our behalf during the pandemic, and to pose any questions that you may have.

o This is also the pinning ceremony for lifetime members – only Dr. Chinese has responded which is a bit disappointing. Please reach out to anyone you know on the list I sent, and I will do my best to get their biographies in on time.

- There were 3 dues waivers requested this month: 1 approved at 100%, 1 approved at 50% and one denied due to frequency.

- We are scheduled to vote today on the continuation of Zoom meetings for the remainder of the year.

- I am compiling an ongoing excel spreadsheet for term start/end dates in the different leadership positions. If you head a delegate, council, or committee, please let me know your start date.

Regarding the request at the last TM to follow the "resolution" which places a 5 year term limit on NJDA Council Chairpersons, after thorough review of the by-laws, we have not been able to find language to that affect. It is the feeling of the executive officers that we can't replace a chairperson from any of these councils without an actual recorded motion that can be produced, or without a by-laws change, or without cause.

Our list of trustees and NJDA council members is due to the NJDA by February 1. Therefore, if there is an anticipated change or vacancy to any position, please let us know as soon as possible.

Executive board of the MOCDS will reevaluate the councils and committees. The By Laws committee will also be contacted in order to cross reference the past amendments and to have them updated. Previous Newsletters with Meeting minutes will be uploaded to the one drive for future reference.

Treasurer's Report (Dr. Sones):

All accounts are in good standing. *Account balances will be made available during the meeting.

NJDA Trustee Report (Dr. Furlong):

Please find the unofficial reports for the Nov 18, 2020 (sent as a separate attachment). The minutes will be reviewed for final approval at the next NJDA board of trustees meeting on Jan 20, 2021.

Following are some highlights that I want to share:

Dental Benefits- NJ dentists can charge for PPE if it's disclosed upfront, unless you have a contract that prohibits it. Companies including Delta Dental, Horizon, Guardian, and United Concordia are paying participating EFT enrolled providers at varying levels through part or all of 2020. The number of Medicaid providers in the country is declining while the number of recipients is increasing. Medicaid is not covering PPE expenses. In NJ there is a back-up for OR cases of up to a year or more; dental OR does not generate the same revenue as other OR cases. A Medicaid provider in Iowa was audited for providing prophies to children 3 and under and he had to repay the money. It can happen in NJ. Telehealth is only covered by Medicaid if the patient contacts the Dr (not the other way around). Governmental and Public Affairs-Jim Shultz discussed how NJ was the first to introduce legislation allowing a nominal fee to be charged for PPE during a pandemic. The legislation provides the State Board of Dentistry to set the fee to alleviate price gouging concerns. NJ will be the first in the country to prohibit the disallow clause by insurance carriers. When it becomes law, no carrier/contract would be able to have a clause that prevents dentists from charging for a service they provide if the insurance does not cover that service. The carriers are opposed to it. NJDA is working on legislation to require carriers to reimburse or credit the insured for unused dental benefits, and also looking at a regulation to exempt PPE from taxes. The 2021 elections are expensive and important. Our relationships with

public offices are critical in determining our fate. Dr's Weiner, Velazquez, Whitman, and Jim Shultz are involved in developing a statewide Oral Health Plan with Dr. Hayes in the Dept. of Health. They are drafting a report to help develop a plan for Q1 2021. NJDA is trying to hold off mid-level providers at the hygiene level but we are the minority. SUPPORTING PAC SHOULD BE A PRIORITY, AND ALL TRUSTEES SHOULD BE CLUB LEVEL SUPPORTERS. LEADERS MUST SET THE EXAMPLE FOR MEMBERS.

Membership-since last year, active members have decreased, retired life members have increased, and new members have increased. We expect 96% of last year's dues revenue through Feb 2021. About 6% of dental practices have shut down.

Executive Director-Art Meisel reported NJDA hired Jennifer Souka (spelling?) to be an administrator in dental benefits and in peer review. The SDC lawsuit is before the appellate division. In NJ you can only own a dental practice if you're a dentist. Ownership means control over what happens in the practice.

Vice President- Dr DeSciscio reported that mannequins will be accepted for board exams in 2021. The State Board is short-staffed, and licenses have been delayed. Virtual meetings with the State Board are not ideal because it's difficult to interact and clarify information. When the Div. of Consumer Affairs brings legislation to the NJ State Board, NJDA can communicate to assist and explain.

Old Business-Dr Velazquez reported that the Social Media task force has been created, and the Champions of Action from each component were asked to sit on the committee. Each component should increase their social media presence. We should like and share posts. We need to flood positive messages to overshadow any negatives.

New Business-Peer Review is a member benefit, and it also provides a community service. In the past we've offered this to non-members, and we would invite them to join. In the past 2 years, peer review was used for about 60% members and 40% non-members. THE NJDA WANTS TO KNOW HOW WE FEEL ABOUT PEER REVIEW.

SHOULD WE OFFER THIS ONLY TO MEMBERS, SINCE IT IS A MEMBER BENEFIT?

SHOULD WE ALSO OFFER PEER REVIEW TO NON-MEMBERS, AS A PUBLIC SERVICE?

NJDA will be messaging through social media, as well as the Monday morning ebalsts, to keep get information to our members in "real time".

I will bring any concerns, as well as the opinion of the MOCDS board about peer review, back to the NJDA board on January 20.

COUNCILS:

Council on Annual Session (Dr. Andricsak):

- The conference is virtual and running from March 1-March 19.
- There is a pay one price ticketing. It allows the virtual attendees access to the digital marketplace and to sign up for as many courses as they choose, including practice management and clinical studies.
- The pay one price ticket includes up to 40 CEU's. That allows attendees to satisfy ALL state board licensure requirements for this renewal period.

• The ticket also includes a Marketplace voucher redeemable with participation vendors listed in our Marketplace Shopping Guide or on a Marketplace Meet-up opportunity. This will ensure vendor engagement from our attendees
