WHY JOIN THE NJ DENTAL POLITICAL ACTION COMMITTEE?

Benjamin Franklin said, “We must all hang together, or assuredly we shall all hang separately.” How appropriate when one talks about assuring the vitality of dentistry. Having served in a leadership role in dentistry for many years, I assure you there is strength in numbers, and power when there is unity among colleagues.

All too often, we become absorbed in our daily routine, and we often forget about those outside influences that have a tremendous effect on the way we treat our patients and how we manage our businesses. Legislators, regulators, insurance companies and countless others constantly barrage dentistry with overbearing rules and regulations that affect what we do and how we do it.

The most effective means of addressing these immense challenges is with a conversation. Conversations that educate non-dentists who need to understand us and the impact their actions can have on our businesses and the patients we treat. Dentistry has these conversations because of relationships that have been built through our political action – NJDPAC.

Strong relationships are critical to ensure we tell our own story and not be subjected to others who simply do not understand. Political action is paramount to building and strengthening these political relationships. It is the best pathway to meet and develop relationships with the state and local elected officials.

In 2021 less than 24 percent of NJDA members contributed to NJDPAC. As of today we are at 20% for 2022. That’s not adequate to face current and future challenges like corporate ownership, direct-to-consumer dentistry, mid-level providers, reduced reimbursement, third party interference, student debt, and needless overregulation. We need to do better, and we can!

Help us push our Disallowed bill to the finish line. Appreciate the work that went into having dentists declared essential health care providers during the pandemic. The Federal and State funding that so many dentists received saved many practices. Let’s not forget the work that has been done at the State and Federal level in holding off a dental benefit in Medicare.

Please join me today as a contributor to the NJ Dental Political Action Committee. NJDPAC does not support a political party. It supports our profession. Join me and take your seat at the table and be heard, otherwise you can be assured that our profession will be on the menu.

We are still looking for someone to head up the Annual Sessions. Installation of Officers: will aim for organizational BOT but can also set up a different time with NJDA officers.

Committee on Budget and Finance (Dr. Albin):

All accounts in good standing. Further discussion regarding donations to JSUMC/MMC to occur via email. JSUMC has been very supportive of our organization for decades and we would like to show our appreciation. Details to be discussed.

Committee on General Membership and Educational Programs

(Dr. Gupta and Dr. Seto):

We had 39 people attend our April dinner meeting, including two Jersey Shore residents. Attendance for the March and April meetings have been submitted to the AGD for our general dentist members to earn CE credits toward their FAGD/MAGD/LLSR. Akriti and I have been starting conversations with some of the younger members who have attended meetings about the BOT and encouraging them to join and get more involved if they are interested.

NJ Dental Lifeline Network (formerly Donated Dental Services)

(Dr. Feeney):

Please accept the semi-annual report (7/1/22- 12/31/22) as the most recent update to NJDLN activities.

Highlighted are 235 patients served and \$452,983 value of statewide donated treatment by 588 dentists (195 specialists/393 generalists).

\$5.49 worth of treatment for every administrative dollar spent. Each patient received an average of \$4,405 worth of care.

5 new volunteer dentists were recruited.

Disabilities of patients were mostly cardiac, musculoskeletal disorders ,autoimmune diseases, mental health ,elderly and cancer.

M-OCDS volunteers have completed 18% of all the state's patients!!

M-OCDS volunteers are responsible for 14% of the total \$value that was generated!!

M-OCDS has 4 past presidents who currently serve out of 17 volunteer administrators!!

This is magnanimous upon considering M-OCDS membership is about 9% of the NJDA membership!!

I am proud. to say this reflects the altruistic culture of humanism that is inherent within M-OCDS.

We do need more volunteers from ocean county .please consider this: Since inception NJDLN has treated 9,488 patients that has created \$ 27,493,400 worth of donated care.

If you already volunteer thank you. If not please consider joining us to provide the dignity of a healthy smile for those of our communities who are marginalized .

1. ARTICLE III

Section 20. OFFICE

Question: Should the Constitution provide for an office of the MOCDS? Wording that it may include an office, for flexibility.

2. ARTICLE IV

Section 20. APPOINTING OFFICERS

Question: Should new MOCDS TRUSTEES be selected by the MOCDS Nominating Committee and confirmed by a vote of the MOCDS Board of Trustees, or should new MOCDS Trustees be elected by the General Membership Assembly?

Board of Trustees, not General Membership Assembly - BOT meetings are open to all members, meeting minutes are distributed to all members via newsletter

3. ARTICLE VI

MEETINGS

Question: In an effort to select a term for the general membership meetings which suggests its legislative role, the term general membership meetings has been modified to GENERAL MEMBERSHIP ASSEMBLY. Is this acceptable?

As long as we define the difference between membership and membership assembly.

4. ARTICLE VII

AMENDMENTS

Question: Should a quorum be a stipulation on all votes conducted by the GENERAL MEMBERSHIP ASSEMBLY? If so, what quorum is recommended?

Majority of people present and eligible to vote (ie, students, guests, vendors not eligible to vote).

1. Should a Non-practicing Dentist Member have the privilege of voting or holding an office?

Yes, as long as he/she still maintains an active license vs membership in good standing - need to define "non-practicing dentist member" more specifically

2. Should the annual budget be adopted by the MOCDS Board or the General Membership Assembly?

BOT is responsible.

3. Do we need alternate MOCDS Board of Trustees?

Consider Ameritas Trustees for those who have been trustees and served us, still hold a title but not affect quorum, they are still open to coming to meetings and voice opinions.

Created requirement for attendance at BOT meetings (50%)

New Business:

Dr. Friedman made a motion to accept the proposed budget. Dr. Nebblett seconded. Motion passed (14 yes out of 16).

Good and welfare:

Dr. Feeney made a heartfelt salutation to our President, Dr. Matt Sones

Be aware of identity theft and ransomware attacks.

Congratulations on a great year and for a wonderful staff appreciation event that was a lot of fun!

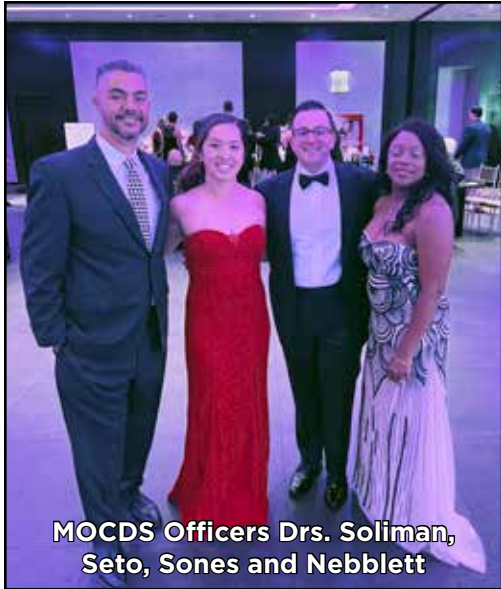

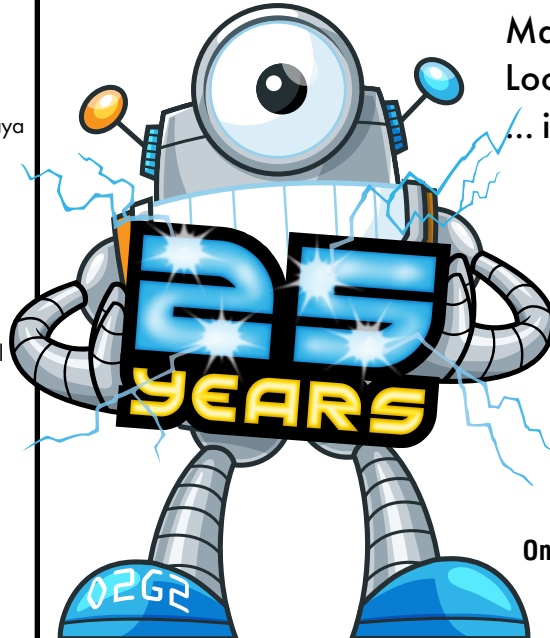

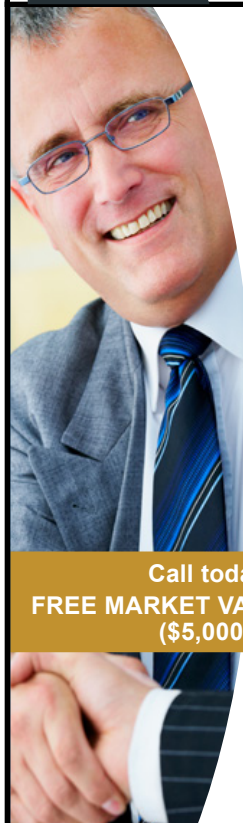
