MOCDS TRUSTEES MEETING MINUTES August 12, 2014

The meeting was called to order by Dr. McTaggart at 7:00 p.m.

Minutes from last meeting: Approved

President's Report (Dr. Mc Taggart):

It is my profound honor to present my first presidents report. I would like to thank you all in advance for what I know will be a great year ahead filled with challenges and many successes. I would especially like to thank Dr. Furlong for making this a seamless transition and providing such detailed notes. Her service to this organization has been invaluable and I hope she continues to provide her expert leadership in organized dentistry in the future.

On July 15th 2014, I met with the past president, vice president treasurer and secretary to discuss some plans for the upcoming year. I am going to invite all non-members to attend one M-OCDS dinner meeting free of charge. If non-members can not make the April meeting but can make another meeting I want them to see the benefits of our society.

NJDA Leadership Conference June 2014 was held for approximately 50 current and future leaders. It was well received. The speaker gave a broad sweeping overview of recruiting current and future leaders with the all important phrase "I (We) need your help". I believe this small phrase will help enormously. I have already been personally contacting current M-OCDS members who I know will be an asset to our organization and asking them to take a more active role in our society.

At the GSDC M-OCDS held an informal toast and gave a small gift for our own Dr. Robert Giantomas who is now Past President of NJDA, we would like to thank him for a wonderful year and wish him the best in the future.

John Kukucka will be transitioning into the chair of the membership committee for Eddie Boim and I would like to thank Eddie for the many excellent years of service. I would like to have all the chairs feedback on their committees and see where help is needed as alternates or members.

Thanks to Dr. Furlong we are in the process of getting PACE approval for our Continuing Education for this year. I am in communication with Dr. Perle and will keep the trustees apprised of the progress.

M-OCDS phone call NJDA

ADA is going to offer a onetime 50% dues reduction to nonmembers 5-10 years out of dental school. We are going to decide how to best get this information to our members.

The next Leadership Meeting will be October 22nd at NJDA headquarters for trustees and officers. I will be giving a 5 minute presentation on our business model. How we plan CE, Promotions, Meetings, New Member Meetings etc.

The Division of Consumer Affairs is extending the last date to use old prescription blanks. You may use the old and new prescription blanks through September 19, 2014. Effective September 20, 2014, prescriptions must be issued only on the new prescription blanks.

Dr. Lisa Indelicato will be assuming the alternate chair of the Dental Benefits committee. She owns a private practice in Middletown NJ with her husband Dr. Chris Armento. She will be attending the next several meetings with Dr. Sirota to get introduced into the committee.

Vice President's Report (Dr. Andricsak):

All accounts are in good standing. Q3 P&L is being reviewed by the officers. Q4 does not end until August 31 and will be reviewed before the October meeting. A transfer of the treasurer duties to the very competent Dr. Angowski is underway.

Treasurer's Report(Dr. Dr. Angowski):

All accounts are in good standing.

Secretary's Report (Dr. Safari):

Executive Committee members, Drs. McTaggart, Andricsak, Angowski, Furlong, and Safari met on July 15th. The duties of each of the officers were discussed. One of the president's primary goals is to add 30 new members to the MOCDS by August of 2015.

NJDA Trustee Report (Dr. Shah):

NJDA July, 2014

ADA is promoting a new program, "Power of Three", to foster cooperation, coordination and collaboration among the three levels of organized dentistry

ADOPTED by the Board (Vote #1 BT-14-7-12 to support Rutgers' Indian Health project in the amount of \$2500.)

ADOPTED by the Board (Vote #2 BT- 14-7-13) to support Rutgers' Research Fellowship in the amount of \$1500.

ADOPTED by the Board (Vote #3 BT-14-7-14) the May 1-2, 2015 date for the 2015 Garden State Conference and Expo to be held at the Princeton Marriott.

ADOPTED by the Board to approve the June 3, 2015 date for the House of Delegates and the Reorganization meeting to be held at the Pines Manor in Edison, N.J.

Communication: Staff Report: Nichole Fredrickson has created on-line web-based forms for CE, Golf Outings, New member applications, etc. We are moving to a new web based format.

Ms. Fredrickson reported that they are working on developing a ge-

neric, prospective member piece to try to entice non-members who would be in the active dues category. In addition, Nichole is working with Maureen Barlow in regards to restarting the use of 'fax blasting'. This is being considered as an option for next year's the Marketing Budget.

Dental Benefits & Peer Review – Ms. Mary Moskal reported that the NJDA submitted comments on the proposed amendments to the regulation defining Unfair Claims Settlement Practices, to include claim payments made by alternative means (e.g., debit/credit cards, electronic payments, etc.) without the voluntary consent of the enrollee. NJDA's comments sought to clarify that the rule would apply to claims payments made directly to treating practitioners, and also requested that the rule specifically include third party administrators.

Dentists who treat Medicare patients with Medicare Part D (prescription drug) coverage must decide by next June to either enroll in, or opt-out of Medicare in order for the prescriptions they write to be covered. The NJDA is also attempting to clarify whether or not a dentist who opts-out of Medicare would be precluded from participating in a Medicare Advantage Plan.

Membership – Ms. Tricia DeCotiis: Mrs. Tricia DeCotiis reported that we have 4,397 members paid to date; sixteen ahead of last year at this time. Current focus is on the non-renews. Rutgers student lunch and learns: This coming academic year NJDA will work with ASDA leaders to arrange speakers for a series of topics the student body is interested in. Lectures will be both during lunch and in the evenings. These will take the place of the class lunch and learns NJDA has hosted in previous years

The Board agreed that we will participate in this SPI with the ADA and staff will proceed with the process of advising the components and asking if the component will participate as well. Mentor Program – Rutgers Alumni Association and ASDA are working with NJDA to develop a new student and new dentist mentoring program. Plans are to kick-off the program in October at a social event to be held at the NJPAC in Newark.

Programs & Development – Give Kids A Smile marketing will begin in September. Last year there were 50 pre-health students that participated which was beneficial for both parties.

Mrs. Barlow gave a brief recap regarding the Annual Session. She reported that we had 1400 members that registered but only 900 attended. She plans to survey those individuals that signed up but did not attend. To date, the finances look okay. CE course attendance was lower but we made up for it in exhibitor sales. She acknowledged Akriti Gupta and all the students who greeted everyone with their packets. They were a beneficial addition in making the registration area run smoothly. We had a panel luncheon for them with different specialists talking to them.

The 2015 Annual Session is scheduled for May 1-2, 2015 at the Princeton Marriott, Princeton, New Jersey. We will set up a room block at the Princeton Marriott as well as with three other properties in Princeton.

The Dental Team Forum will be held October 1st at the Renaissance Woodbridge Hotel. We have 5 speakers lined up, you will receive 6 CE credits, a shredding truck will be available and you can take a digital photo with your team. September 1st we will start working

with the partners for 2015.

Dr. DiVincenzo reported that at the State Board of Dentistry four new appointments were made: Drs. Joseph Battaglia, Steve Goldstein, Elizabeth Clemente and Peter Clemente. Drs. Peter DeSciscio and Lydia David's terms were completed.

Dr. Mark Vitale reported noted that dues revenue was down \$75,000. Dr. Vitale reported that the EBAs were a good source of non-dues revenue and suggested that the Trustees report this back to their component to increase revenue.

Mr. Arthur Meisel reported that he filed with the Supreme Court a Petition for Certification on the overpayment recovery matter. The reply brief is due Monday, July 28th.

Mr. Meisel reported on the status of the Corporate Practice of Dentistry petition with the State Board. He will attend a meeting with a State Board sub-committee on August 6, 2014 to discuss the Petition. Dr. Tom Rossi(CE) and Dr. Dipika Shah(MOCDS) have announced intention to run as a secretary of NJDA.

Dr. Cecile Feldman reported that The new class entering the school in September consists of 90 first year students and 25 international students. Rutgers Dental School has a 90% match rate vs. a mid-60% national match rate. She reported there is a lot of renovation going forward. A new clinic and research lab are being built and renovations are being made to the old clinical and research buildings. They are proceeding with a Recruitment search for the Department of Restorative Diagnostic sciences. The Dean gave an overview regarding faculty. There is a full time faculty shortage and the part time faculty is recruited from dentists in the area.

Council on Annual Session (Dr. Shah):

Council on Annual Session

· 348 NJDA members attended (or about 8% of membership). Dr. Chinoy believed the percentage was similar to attendance at the ADA meeting.

· Hygiene and assisting numbers were equally low among their membership.

· Dr. LaMorte noted that overall there was good cooperation from all the specialties at the 2014 meeting, but asked that other council members volunteer to liaise with the specialty groups. He also said Horizon deserved a thank you for sponsoring, especially in light of a slightly lower than expected turnout.

· Akriti Gupta asked that the specialty program be open to all dental students next year.

Discussion on Future of Meeting and Council

· Dr. Chinoy, as Speaker, noted that the Council does not need to meet 8 times per year, but does need 1 representative per component to disseminate information. Any recommendations made by the Council on Annual Session, such as reducing/eliminating comps, would need to go before the Board. He suggested that each member read the Rules of the Board (enclosed) in this respect.

2015 Conference: Jodie Heimbach, urged the use of coded name badges so that sales reps know who they are meeting in the exhibit halls. It was agreed and will be implemented for 2015. Discussion of whether exhibit hall should be one day or 1 ½ days. By show of hands, the exhibit hall will be 1 ½ days – 9 AM to 6 PM Friday; 9 AM to 1 PM Saturday.

3)Speakers: Current exhibitors and sponsors were contacted to provide speakers for 2015. About 12 companies responded and 8

speakers were chosen. All but about \$3500 in honoraria is covered, including all of featured speaker, Louis Malcmacher. Maureen is still seeking sponsorship for the final \$3500. Dr. Elisa Velazquez, representing the NJ Academy of Pediatric Dentistry, has approached NJDA about holding a course at our conference.

4) Sponsorships & Cost Savings

- Staff is actively seeking sponsorship of items such as tote bags and badge holders. NJDA had success with this in 2014, by having companies donate 100 totes for distribution, rather than one company providing all, or NJDA absorbing the cost.

- The on-site guide, which isn't a successful format for our conference, may be replaced by "You Are Here" signs throughout the Marriott property, plus a pocketed badge holder than can also hold a coupon book of show specials.

- Bank of America is interested in giving out \$25 "bank cards" that would only be good at the conference and only given to NJDA members.

5) Events

- Dinner dance – Dr. Roshong is leaning to having the dinner in his component.

- Comps were discussed – whether to invite out of state leadership to conference, dinner dance or both. Once suggestion was to host out of state guests at a Friday night dinner at the conference, which would be less expensive than at the dinner dance, regardless of where it's held. Dr. Chinoy said the Rules of the Board need to be reviewed and a recommendation about comps made to the Board.

- How to handle comps was tabled until the September meeting.

2015 Pricing – Registration Fees and Packages

- Referring back to the 2014 registration figures, Maureen pointed out that only about 220 attendees took courses. Also, (free) Breakfast & Learn attendance was so low that NJDA had to refund money to the breakfast sponsor. In addition, staff time and resources were used to prepare packets for 550 no-shows.

- Dr. LaMorte felt strongly that members should not be penalized if they decide or are unable to attend the conference. Stan Orenstein said that NJDA currently refunds anyone who cancels in writing.

- Maureen suggested, \$50 registration fee that includes coffee break/continental breakfast, lunch buffet and afternoon coffee break. Or, charge \$150 per person and include up to 3 CE credits with food and beverage.

Council on Dental Education (Dr. Andricsak):

The council on Dental Education met on May 6, 2014

Maureen Barlow, from NJDA, was present to update on the format of the annual session.

The format is being changed. 2014 will eliminate the House of Delegate meeting and the presidents dinner dance. The reason is financial burden. A submission form was given for any member interested in speaking for the weekend study club. Please ask for Maureen if interested in obtaining the form for submission.

It was recommended to check your presence for public view on the NJDA.org website for accuracy.

Frank Bastini continued the discussion on the development of the power point presentation that we are working on as a council so we can present it at our component member meetings. The topic is The Value of CDA/RDA vs non-registered dental assistants. The purpose is to clarify the duties recognized by the state board that can be performed under direct supervision as well as clarifying the pathways in which a potential employee can obtain credentials to perform clinical functions.

An example was given and discussed, in detail, about CBCT machines. The current radiology license held by most dental assistants prohibits the use of the CBCT. Additional training and certification is required from the manufacturer. It is not a one-time training. Each new employee that is to use the machine must be certified by the manufacturer individually which is contrary to what is done. Many offices may think it is ok to train a new employee themselves, however, this is not legal.

The meeting was adjourned.

Council on Governmental Affairs (Dr. Goodwin):

Dr. Haghighi and Dr. Goodwin stated that federal law allows Schedule II E-Scripts however, State of New Jersey does not allow E-scripts on schedule II drugs. MOCDS trustees are requesting executive members of the chapter to contact Jim Schulz, director of government affairs for the NJDA, about the issue.

Council on Nominations(Dr. Shah)

Dr. Dipika Shah is running for the secretary position of the NJDA. The M-OCDS will forward a letter of support for Dr. Shah.

Council on Peer Review (Dr. Angowski):

Dr. Michael Adler and Dr. Cathy Andricsak were nominated and chosen to be part of the GP peer review.

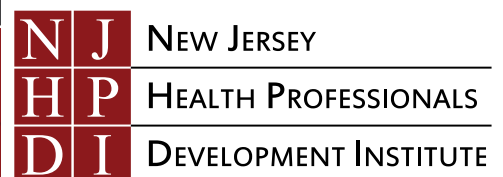
